

SUBJECT : Implementing Guidelines on Enlistment of GE Courses

DATE : 25 July 2018

Please be guided by the following related to enlistment of GE courses for AY 2018-2019:

1. Incoming freshmen shall take or enlist in GE courses, whether reconfigured or newly instituted under the Diliman-21 GE Framework.
2. Continuing students (with Student Nos. 2017 or older) may take or enlist in GE courses, whether reconfigured or newly instituted under the Diliman-21 GE Framework, subject to availability of slots.

Newly admitted shiftees/ transferees may take or enlist in GE courses, whether reconfigured or newly instituted under the Diliman-21 GE Framework, subject to availability of slots.

Please see attached summary report on the availability of slots for new GE courses or Diliman-21 GE courses, as of 17 July 2018.

3. Continuing students and newly admitted shiftees/ transferees shall apply the GE subjects taken earlier for substitution or crediting as soon as possible.
4. Continuing students and newly admitted shiftees/ transferees can take the newly instituted GE courses in lieu of old required/ hybrid GE courses. For instance, Eng 13 can be substituted for Eng 10, Speech 30 for Comm 3 and Math 10 for Math 1.
5. For continuing students and newly admitted shiftees/ transferees, for purposes of satisfying domain-specific requirements, reconfigured GE courses will still be classified under domains per classification presented when UPD approved the 21 GE courses.
